It also lets you import from legacy archives or Exchange.

Essentials Email Archive supports Exchange 2010, 2013, 2016 and Office 365. Whether you use Exchange or Office 365, you can enable journaling and direct email traffic to Proofpoint Essentials. From there, Essentials can then process and store the email based on your retention policies. Data is under management until it is disposed of according to your retention settings. Essentials encrypts archived at-rest data using your unique encryption keys.

Storage Management and Productivity

Essentials Email Archive also improves email storage management and end-user productivity. It features unlimited storage. And it supports retention policies and legal holds of up to 10 years.

Email messages are stored in a centralized archive. Designated users can access their archive from the web. They can search for and read the full email history. They can also retrieve past messages and forward them to others.
